BBHCA Meeting and Candidate's Night Sept. 17

Please join us at Bush Hill Elementary for the Brookland-Bush Hill Community Association meeting, beginning at 7:30 pm on Tuesday, Sept. 17th. The plan for this meeting was hear from the candidate's running for the Lee **District Supervisor position** being vacated at the end of the year by Jeff McKay, who has worked closely with our neighborhood for many years. However, we've learned that following the primaries this summer, Rodney Lusk will be running unopposed for the Supervisor position. We are therefore exploring a couple of options. One is to bring in candidates from one of the lower profile races—the Soil And Water Conservation District apparently has 7 candidates competing for Director, and it might be very interesting to hear from them as they are expected to play a big role in land use decisions as the development pressure in our area increases. Another com-

peted office is the county Sheriff, which has two candidates who will presumably have different visions of the future of law and order in Fairfax County. There are also several candidates for the At Large positions on the School Board, and so this would provide a good opportunity to ask about the dangerous congestion around Bush Hill Elementary in the mornings. You can check the website bbhca.net prior to the meeting to see which candidates will attend. In either case, I think we can expect a very interesting evening, and you will have the opportunity to ensure that the candidates for these offices hear about the issues that are important to you.

Treasurer's Report:

A copy of the Income and Expense spreadsheet was distributed. Income received this fiscal year: Membership dues \$2,130.00, donations \$410.00, and ads \$1080.00 for a total income of \$3,626.32. Expenses include the BBHCA newsletter and Liability Insurance for a total of \$1,588.62 for a profit of \$2,037.70.

Presentation by Fairfax County (FFC) Police:

Six metro stations in Northern Virginia will be closed down during the summer of 2019:

Braddock Road, King Street, Eisenhower Avenue, Huntington, Van Dorn Street and Franconia-Springfield. Scheduled to reopen September 9, 2019.

Crossing guard – short on guards which is why there is not a crossing guard at the elementary school. People are not applying as this is a part-time job with benefits but is not attracting applicants. We do not have the budget to make this a full-time opportunity.

FFC – Ten Police Officers on shift for all of Franconia and two traffic enforcement officers.

FFC will visit your home, upon request, to assess how to make your home more security safe.

Car break ins are partially due to unlocked cars. People feel safe so they aren't locking their cars. Break ins are mostly occurring at night. More noticeable police officers are driving thru the neighborhoods since the break ins.

Bush Hill Elementary – increased traffic, especially due to construction at the school. People parking everywhere and speeding through the neighborhood, blocking roads and creating issues. Advanced academics will increase traffic next year. Recommend contacting VDOT or the Fairfax County Board of Supervisors for increased parking on curve of Westchester Street. Call the police non-emergency phone number, 703-691-2131, for all other parking complaints in the neighborhood. Discussion on coordinating a response with the school specifically the principal and then Jeff McCay's office.

A co-located police station and animal shelter are coming to Lorton. The facility will house the new South County Police Station. It is de-

Land Use Update

Oakwood Senior Housing

Just an update on this application. County Staff presented this application to the Lee District Landuse Committee on July 8, 2019.

As a reminder, this application, PA 2019 IV-RH1v (case number), is to change the comprehensive plan language to be consistent with this use. The plan currently identifies this site as open use, however the land is zoned R8 (residential, 8 dwelling units per acre) and was approved for 150 town house units.

This presentation was to address the plan amendment, not to review the site plan, which is still in development. That said, staff did present a preliminary site diagram that took into consideration the modifications to the building after the property walk through.

Current plan for the plan amendment:

- 21 August: staff report is published
- 09 September: presentation to landuse
- 11 September: Planning Commission, Public Hearing
- 24 September: Board of Supervisors

The committee focus was storm water management, transportation and parking. These items will be addressed in more detail when the site plan is brought before landuse.

signed to serve the residents and businesses of southern Fairfax County and should improve response times for Lorton residents who currently live on the outer fringes of the Franconia and West Springfield District Stations' coverage areas. The new station will be located on Lorton Road between Workhouse and Hooes Road. Ground breaking is scheduled for 2022.

A discussion ensued on FFC preparedness. A recommendation was to have a Neighborhood Emergency Preparedness Plan. It would include information such as, who in the neighborhood that would be available to help out, who has special skill sets, and what resources would be available during an emergency or a disaster. Looking for volunteers to develop a plan.

partment of Emergency Management (VDEM) is marking the 50 year anniversary of Hurricane Camille's catastrophic arrival in Virginia. This storm was the deadliest natural disaster in Virginia history, causing massive inland flooding and mudslides that left more than 150 people dead and permanently altering the landscape in many areas. A staggering 27 inches of rain fell overnight, washing away or damaging over 100 bridges, railways and roads, and damaging or destroying more than 900 buildings. VDEM is encouraging Virginians to remember that major natural disasters can, and do, happen in Virginia, and that preparation is both necessary and effective at saving lives.



Some key resources are on-line at DCR.virginia.gov/vfris, where you can learn the flood risk for your home. Also, see VAemergency.gov/hurricanes to find a list of advance steps that will help you prepare, both physical and financially, your home and family for an event. (One insurance hint: document your property with a camera before a storm hits).

Of course, hurricanes are not the only disaster of concern in our area, as the recent gas explosion in Maryland has demonstrated. VDEM, like Fairfax County, is encouraging organizations like ours to take concrete steps to build a more resilient community, and at our meeting in May we took the first steps in discussing the neighborhood framework recommended in the Fairfax County Community Emergency Response Guide plan. We received strong interest from members with key skills, but more players are needed to fill out the team that is required for this effort. We will continue to discuss and recruit around this issue--- please come to a meeting to learn more.
